Assertion (A) : Choke coil is simply a coil having a large inductance but a small resistance. Choke coils are used with fluorescent mercury-tube fittings. If household electric power is directly connected to a mercury tube, the tube will be damaged.

Reason (R): By using the choke coil, the voltage across the tube is reduced by a factor $\left(\frac{R}{\sqrt{R^2 + \omega^2 L^2}}\right)$, where ω is frequency of the supply across resistor R and inductor L.
